Dear Theatre Equus Performer:

Thank you for joining us as a performer for Theatre Equus. The following information concerns your organization's participation in horse related activities during Theatre Equus, A Musical Equine Review. Theatre Equus is a professionally choreographed and scripted performance with shows scheduled for **Friday, March 6 and Saturday, March 7**, beginning at 8:30 pm and lasting approximately 2 hours. In addition to the two evening performances, a **mandatory dress rehearsal will be held on Thursday, March 5**, beginning at approximately 6:00 pm. All performers should attend the rehearsal in full costume and be prepared to perform their routine at least twice. Additional practice runs may be required if deemed necessary. We ask that you schedule a minimum of four hours for the rehearsal. Our Theater Equus Director, Wayne Williams, will contact you prior to the performance. He will provide additional information about the show, assist you in preparing and answer any questions you may have. The Director will have the final say on all acts and performances as well as order of go. We have delegated this responsibility in an effort to assure a smoothly running show, one that flows from one act to the next with a common theme.

All Theatre Equus performers are required to conduct themselves in a professional manner during their performances to a family audience. Costumes are to be appropriate for an all-age audience, properly cleaned, maintained and of high quality to reflect the professional manner in which this show is conducted. All horses are to be properly groomed, clipped and, if appropriate for your performance, banded or braided. Additionally, all horses should be conditioned for a professional indoor event that includes loud noises, spot lights and darkened arena environments. Each of our acts has been carefully selected to provide top notch equestrian entertainment to a family audience.

All performers should plan to provide all necessary props for their performance unless arranged in advance with Equestrian Promotions, Inc. A request for props should be made in writing and submitted with the other forms requested in this package. Our Theater Equus Director will coordinate all music for the performances. If you have special music that you will use during your performance, please arrange this with him in advance.

A show program will be distributed to the public before and during Theatre Equus. Please forward immediately via email to info@horseworldexpo.com the following information: high resolution color publicity photos, a brief description of your act(s), performer's biographies and how you would like the name of your performance and performers to appear in the program.
